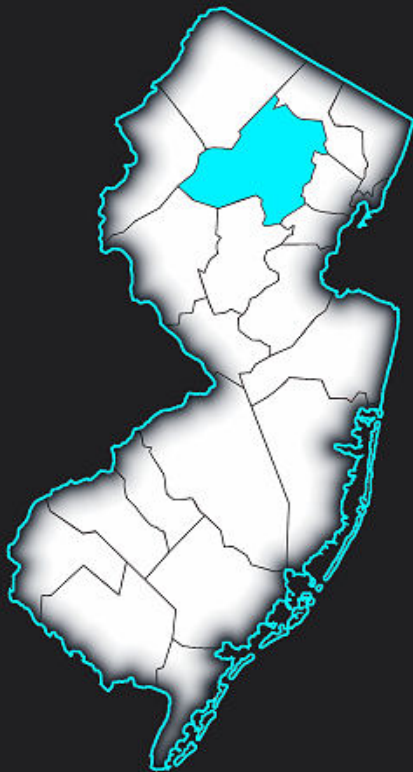

# MORRIS COUNTY CLERK'S OFFICE

*My position as a Constitutional Officer is an office that is elected every five years by the Morris County Voters. The first priority for my office is for the public to receive courteous, efficient and customer friendly service for all the residents who do business in my office. The County Clerk is responsible for the administration of a broad range of services which include the following:*

**PROPERTY RECORDS:** My office records and preserves all documents pertaining to property holdings in the County. All deeds, mortgages and various liens are recorded here and available for use by the general public. They are also of special interest to attorneys, title searchers, historians and genealogists. All major and minor sub-division maps are maintained by this office. 12,548 deeds and 33,866 mortgages were recorded with the Clerk's Office in 2007. This office also processed 14,078 mortgage cancellations and 19,213 discharges.

**OTHER DOCUMENTS:** All Notary Publics who reside in Morris County are sworn in and their records maintained in this office. Trade Name Certificates are recorded here as well as Veterans' Discharges, Attorneys' Certificates of Good Standing, Naturalization records, Physicians Diplomas, early Marriage Certificates (to 1878), Vendors' Licenses and Fireman's Exempt Certificates. 1,616 Notary Publics were sworn in last year, and 1,119 people registered new businesses/trade names in Morris County.

**PASSPORTS/COUNTY ID'S:** The Passport Office provides many special services such as Wednesday evening hours, Special Delivery service and a Courier service to the Philadelphia Passport Office for residents with emergency travel plans. There were 10,471 passports processed in Morris County in 2007. Last year, our evening passport on the road program was taken to 3 different municipalities. A County Identification Card is available as well as a Special ID Card with fingerprints for children.

**ELECTIONS:** My Election Office is responsible for preparing, printing and distributing all absentee, machine and sample ballots for the Primary, General, School Board and Special Elections in Morris County. All results from Federal, State and County-wide races are tabulated and certified by this office. 1,455 absentee ballots were issued in the Primary Election, 3,843 in the General Election. There were also 3 Special Elections held in 2007.

**WEDDINGS:** As County Clerk I am authorized to perform weddings by the State of New Jersey. 236 weddings were performed here last year. Since 1999 I have performed 1,543 weddings.

**REVENUES:** In 2007, \$ 75,983,784.50 was collected by this office and turned over to the County Treasurer. 122,343 various documents were processed here last year.

### **DIRECTIONS TO THE COURTHOUSE COMPLEX and COUNTY ADMINISTRATION & RECORDS BUILDING**

**From Trenton and Southern NJ:** Take I-287 N. to exit 35 (South St.) make a left onto South St. (becomes Rt 124). Continue west on South St. to the park (Morristown Green). Go three-quarters around the Green and turn right onto Washington St. The Courthouse & County Administration Building are two short blocks from the Green on the left.

**From Northern NJ and NY City:** Take I-80 W. to I-287 S. to exit 36 (Morris St.) Follow Morris St. to the park (Morristown Green), go half-way around & turn right onto Washington St. The Courthouse & County Administration Building are two short blocks from the Green on the left.

**From Newark Airport:** Take I-78 W. to Rt 24 W. At the end of Rt 24 take I-287 S. to the next exit (#36 Morris St.). Follow Morris St. to the park (Morristown Green), go half-way around & turn right onto Washington St. The Courthouse & County Administration Building are two short blocks from the Green on the left.

**Using Bus or Train Service:** Morris County Metro bus service to the center of Morristown is available from many Morris County towns, for information call (973) 328-7686. NJ Transit operates frequent passenger train service to Morristown, 1-800-772-2222. New York City to Morristown buses are operated by Lakeland Bus Line (973) 366-0600 and Community Coach 1-800-522-4514 in NJ and in NY (212) 662-3530.

### **COUNTY LIBRARY & FRELINGHUYSEN ARBORETUM**

**From Trenton or Southern NJ:** Take I-287 N. to exit 36A (Morris Ave. [one-way]) and keep to the middle lane, which becomes Whippany Rd. (County Rt. 511). Turn left onto E. Hanover Ave. (County Rt. 650). The Library will be on the right and across the street is the Arboretum.

**From Northern NJ:** Take I-80 to I-287 S. to exit 36 (Ridgedale Ave.). Turn right onto Ridgedale Ave. and at the traffic light turn right onto E. Hanover Ave. After crossing over I-287 the Library is on the left and the Arboretum is on the right.

**From Newark Airport:** Take I-78 W. to Rt. 24 W. At the end of Rt. 24 take I-287 S. to the next exit (#36 Ridgedale Ave.) Turn right onto Ridgedale Ave. and at the traffic light turn right onto E. Hanover Ave. After crossing over I-287 the Library is on the left and the Arboretum is on the right.

### **MORRIS VIEW, PUBLIC SAFETY TRAINING ACADEMY & OTHER WEST HANOVER AVENUE COUNTY OFFICES**
