- 3. That in aggregate the number of valid signers of the petition(s) equal or exceed the number required by law.
- 4. The person in whose presence the petition was signed must make the affidavit before an officer authorized by law to take affidavits.
- 5. That the candidate(s) endorsed in the petition fully complete and execute the Oath of Allegiance (page 17) before a notary or other officer authorized to take oaths and they also must sign the Certificate of Acceptance stating that he/she is qualified for the office.
