Boonton Town: **RESOLVED** that there should be raised an additional **\$89,700** for general funds in the same school year 2002-2003. These taxes will be used exclusively to renovate the existing tennis courts on the Maple Avenue extension. These proposed additional expenditures are not required by law and are in addition to those necessary to achieve the Core Curriculum Content Standards.

PROPOSAL

Morris Township:

The Board of Education of the Morris School District in the County of Morris, New Jersey is authorized to purchase a bus depot, located at 120 Ridgedale Avenue, Morristown, New Jersey. The Board of Education is further authorized to expend an amount not to exceed \$1,050,000 to purchase the bus depot and to transfer the following amounts into the capital projects fund for such acquisition: (I) \$571,203.97 of unspent bond proceeds from a \$11,080,000 bond referendum approved by the voters of the School District on September 28, 1998; (II) \$427,893.69 from the capital reserve account; and (III) \$50,902.34 from General Fund Surplus.

The acquisition of the bus depot by the Board of Education is not eligible for State financial assistance under the Educational Facilities Construction and Financing Act.

Interpretative Statement

The Board of Education is requesting approval to use unspent bond funds from a previously approved bond referendum to acquire a bus depot. The improvements authorized by the voters at the September 28, 1998 special election are complete and the Board of Education now wants to use a portion of the unspent bond funds from that project to acquire a bus depot. When the \$571,203.97 of unspent bond proceeds are combined with the \$427,893.69 from the capital reserve account and \$50,902.34 from General Fund surplus, the Board of Education will have \$1,050,000 to deposit into the capital projects fund to acquire the bus depot. Riverdale Borough: Further Resolved that there should be raised an additional \$222,521.00 for General Funds pursuant to N.J.S.A. 18A:7F-5d(9) to maintain one part-time guidance counselor, partial funding for transportation costs for field trips and athletic events, maintain one full-time Librarian, maintain two full-time elementary teachers (grade 2 and grade 4), partial funding for extra-curricula student activities programs, partial funding for athletic programs, baseball and softball, maintaining summer school, maintaining a hot lunch/food service program which the district is not required by law to do, and benefits associated with the teachers identified above.
