PUBLIC QUESTION TO BE VOTED UPON

BOND PROPOSAL QUESTION

The Board of Education of the Township of Mendham in the County of Morris, New Jersey is authorized: (a) to provide for renovations, alterations, and improvements at Mendham Township Elementary School and Mendham Township Middle School, including acquisition and installation of fixtures, furnishings and equipment, site work and related costs; (b) to appropriate \$19,903,197 for such purposes and (c) to issue bonds of the school district therefore in the principal amount of \$19,903,197.

The final eligible costs of the project approved by the Commissioner of Education are \$18,475,992 (with \$8,272,041 allocated to Mendham Township Elementary School and \$10,203,951 allocated to Mendham Township Middle School). The proposed improvements include \$257,400 allocated to Mendham Township Elementary School and \$257,400 allocated to Mendham Township Middle School for elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the project. The Board of Education is authorized to transfer funds among the purposes approved at this special election.

INSTRUCTIONS FOR VOTING

- Please read through the instructions completely. After inserting the card given to you by the poll worker, insert it into the card slot in the device to the right, cut corner of the card in the upper right.
- Touch **YES** or **NO** on the **PROPOSAL** to make your selection. Your selection will turn **Green**. To Change your selection, touch the **Green Box** again and it will de-select your choice. You may make a new selection.
- When you have completed voting and verified your selection, touch the **Green "Print Ballot"** button on the lower right side of the screen. A confirmation message will first be displayed to **"Return to Ballot" or "Print"**.
 - To make any changes before printing the voter paper audit trail, touch **"Return to Ballot"**.
 - To proceed with printing the voter paper audit trail, touch **"Print"**
 - This will print your selection on the card and display it in the printer window for your review.
 - Review the card to ensure it represents your selection accurately. Then touch the **"Cast"** button only if what is displayed on the card accurately reflects your choice.
 - If changes need to be made after printing the Voter Paper Audit Trail, touch the **"Quit"** button to cancel the voting session. A poll worker will be signaled to assist you. You must return your spoiled paper audit trail folded to the poll worker in order to receive a new activation card to start the voting process over.

Official Special School Election Sample Ballot
