INSTRUCTIONS FOR VOTING

1. Please read through the instructions completely. After inserting the card given to you by the poll worker, insert it into the card slot in the device to the right, cut corner of the card in the upper right.
2. Touch **YES** or **NO** on the **PROPOSAL** to make your selection. Your selection will turn **Green**. To Change your selection, touch the **Green Box** again and it will de-select your choice. You may make a new selection.
3. When you have completed voting and verified your selection, touch the **Green "Print Ballot"** button on the lower right side of the screen. A confirmation message will first be displayed to **"Return to Ballot"** or **"Print"**.
 - To make any changes before printing the voter paper audit trail, touch **"Return to Ballot"**.
 - To proceed with printing the voter paper audit trail, touch **"Print"**
 - This will print your selection on the card and display it in the printer window for your review.
 - Review the card to ensure it represents your selection accurately. Then touch the **"Cast"** button only if what is displayed on the card accurately reflects your choice.
 - If changes need to be made after printing the Voter Paper Audit Trail, touch the **"Quit"** button to cancel the voting session. A poll worker will be signaled to assist you. You must return your spoiled paper audit trail folded to the poll worker in order to receive a new activation card to start the voting process over.

PUBLIC QUESTION TO BE VOTED UPON

BOND PROPOSAL QUESTION

The Board of Education of the Borough of Morris Plains in the County of Morris, New Jersey is authorized (a) to construct an addition at Mountain Way School, including acquisition and installation of fixtures, furniture, equipment and any site work; (b) to undertake various improvements, alterations, renovations, repairs and upgrades to the restroom facilities at Morris Plains Borough School, including acquisition and installation of fixtures and equipment; and (c) to appropriate \$9,498,051, and to issue bonds in an amount not to exceed \$9,498,051.

The final eligible costs for the projects approved by the New Jersey Commissioner of Education are \$2,295,426 (consisting of \$37,761 for Mountain Way School and \$2,257,665 for Morris Plains Borough School). The project includes \$958,100 (consisting of \$958,100 for Mountain Way School and \$0 for Morris Plains Borough School) for school facility construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the projects approved at this special election.
