IMPORTANT! ATTENTION VOTERS! IN-PERSON EARLY VOTING IS AN OPTION - STARTS SAT. OCT 25 THRU SUN. NOV 2

As a result of legislation enacted into law, the State of New Jersey will be offering in-person early voting on a machine during a nine day period. In addition to providing early voting, registered voters will continue to have the option of voting by mail or in-person at their polling place on Election Day. There will be 8 early voting sites throughout Morris County. Electronic poll books will be used to sign-in voters. Poll workers will be available to assist all voters in using these devices. The early voting locations are listed below. Hours for early voting are Monday-Saturday, 10am to 8pm and Sunday 10am to 6pm. It doesn't matter where you live in Morris County - You can go to any of the 8 sites and conveniently cast your ballot on a voting machine.

Official General Election Sample Ballot

In cases where the sample ballot is to be sent an addressee who does not receive his mail by delivery to his home or through rural free delivery 'if not delivered within five days return to the Superintendent of Elections' and in all other cases 'if not delivered within two days return to Superintendent of Elections.' PUBLIC QUESTION

Shall the County of Morris amend the Morris County Open Space, Farmland, Floodplain Protection and Historic Preservation Trust Fund to include the purpose of stewardship of permanently preserved lands acquired for recreation and conservation purposes that are designed to restore or enhance its utilization for those purposes and allow the use of previously collected funds for those purposes?

A "YES" vote will permit the County of Morris to include natural resource management, habitat restoration and wildlife stewardship as eligible activities on permanently preserved land acquired for recreation and conservation purposes. These include projects that are designed to enhance or restore the land's utilization for those purposes as eligible activities funded as part of the Morris County Open Space, Farmland, Floodplain Protection and Historic Preservation Trust Fund. A "YES" vote will not increase the tax.

QUESTION:

The Separate Proposal is for construction costs necessary to renovate the second floor of the Riverview Annex to improve the four (4) existing classrooms, common areas, bathrooms, and storage areas; for the employment of additional certificated and/or non-certificated personnel; and for the continued maintenance of the Riverview Annex, at a cost of \$700,250. Voter approval of this proposal will represent a permanent increase in the tax levy of

Supporting Statement:

The Separate Proposal covers construction costs necessary to renovate the second floor of the Riverview Annex in the 2026–2027 school year. The renovations will improve the four (4) existing classrooms, common areas, bathrooms, and storage areas, thereby providing additional instructional space to accommodate the Denville Township School District's K–8 enrollment expansion. In subsequent years, the funds will be used for the employment of additional certificated and/or non-certificated personnel and for the continued maintenance of the Riverview Annex, at a cost of \$700,250 per year. Voter approval of this proposal will result in a permanent increase in the tax levy of 1.83%, meaning the local school tax levy will increase by that percentage and the actual dollar amount of the increase will become part of the base budget moving forward.

INSTRUCTIONS FOR VOTING

- 1. Please read through the instructions completely. After receiving the Ballot Card given to you by the poll worker, insert it into the card slot on the device to the right, cut corner of
- the card in the upper right.
 Touch candidate names and Questions YES or NO to make your selections. Your selection will turn Green. To change your selection, touch the Green Box again and it will de-select that selection. You may make a new selection.
- To write-in a candidate, select the Write-In box, in the last column, across from the office you wish to write-in. A keyboard will appear. Type in the first and last name of the person of your choice. Touch "Accept". Your write-in choice will appear on the ballot.
 When you have completed voting and verified your selections, touch the Green "Print and Review" button on the lower right side of the screen. A confirmation message will
 - To make any changes before printing the voter paper audit trail, touch "Return to Voter "
- FOR VOTING
- To proceed with printing the voter paper Ballot, touch "Print". This will print the candidates you have selected on the Ballot card and display it in the printer window for your review.
- Review the Ballot card to ensure it represents your selections accurately. Then touch the "Cast Your Ballot" button only if what is displayed on the Ballot card accurately reflects your choices.
- If changes need to be made after printing the Ballot card, touch the "Quit" button
 to cancel the voting session. A poll worker will be signaled to assist you. You must
 return your spoiled Ballot card folded to the poll worker in order to receive a new
 Ballot activation card to start the voting process over.
