As a result of legislation enacted into law, the State of New Jersey will be offering in-person early voting on a machine during a nine day period. In addition to providing early voting, registered voters will continue to have the option of voting by mail or in-person at their polling place on Election Day. There will be 8 early voting sites throughout Morris County. Electronic poll books will be used to sign-in voters. Poll workers will be available to assist all voters in using these devices. The early voting locations are listed below. Hours for early voting are Monday-Saturday, 10am to 8pm and Sunday 10am to 6pm. It doesn't matter where you live in Morris County - You can go to any of the 8 sites and conveniently cast your ballot on a voting machine.

PUBLIC QUESTION TO BE VOTED UPON

OPEN SPACE TRUST FUND REFERENDUM:

Shall the Pequannock Township Council adopt an Ordinance revising the permitted uses of the Open Space, Recreation, Farmland and Historic Preservation Trust Fund, currently codified as Section 5-112 of the Pequannock Township Code, to allow the Open Space, Recreation, Farmland and Historic Preservation Trust Fund to broaden the purposes for which it may be used to include all purposes authorized by N.J.S.A. 40:12-15.7 specifically including the purpose of stewardship of permanently preserved land acquired for recreation and conservation purposes that are designed to restore or enhance its utilization for those purposes, and allow the use of previously collected funds for these purposes.

INTERPRETIVE STATEMENT:

This proposal will give Pequannock Township greater flexibility in its use of the funds in its Open Space, Recreation, Farmland and Historic Preservation Trust Fund. A "Yes" vote will mean the voters want to maximize the purposes for which the fund can be used to include natural resource management, habitat restoration and wildlife stewardship as eligible activities on permanently preserved land acquired for recreation and conservation purposes in addition to other purposes within the limits allowed by state law.

EARLY VOTING & ELECTION DAY

INSTRUCTIONS FOR VOTING

1. Please read through the instructions completely. After receiving the Ballot Card given to you by the poll worker, insert it into the card slot on the device to the right, cut corner of the card in the upper right.

2. Touch candidate name to make your selection. Your selection will turn **Green**. To change your selection, touch the **Green Box** again and it will de-select that selection. You may make a new selection.

3. To write-in a candidate, select the **Write-In box**, in the last column, across from the office you wish to write-in. A keyboard will appear. Type in the first and last name of the person of your choice. Touch **"Accept"**. Your write-in choice will appear on the ballot.

4. When you have completed voting and verified your selections, touch the **Green "Print and Review"** button on the lower right side of the screen. A confirmation message will first be displayed to **"Return to Voting"** or **"Print"**.
 - To make any changes before printing the voter paper audit trail, touch **"Return to Voting"**.
- To proceed with printing the voter paper Ballot, touch **"Print"**. This will print the candidates you have selected on the Ballot card and display it in the printer window for your review.

Review the Ballot card to ensure it represents your selections accurately. Then touch the **"Cast Your Ballot"** button only if what is displayed on the Ballot card accurately reflects your choices.

If changes need to be made after printing the Ballot card, touch the **"Quit"** button to cancel the voting session. A poll worker will be signaled to assist you. You must return your spoiled Ballot card folded to the poll worker in order to receive a new Ballot activation card to start the voting process over.
