- Please read through the instructions completely. After inserting the Ballot Card given to you by the poll worker, insert it into the card slot on the device to the right, cut corner of the card in the upper right.
- Touch candidate names to make your selections. Your selection will turn Green. To change your selection, touch the Green Box again and it will de-select that candidate. You may make a new selection.
- To write-in a candidate, select the Write-In box, in the last column, across from the office you wish to write-in. A keyboard will appear. Type in the first and last name of the person of your choice. Touch "Accept". Your write-in choice will appear on the ballot.
