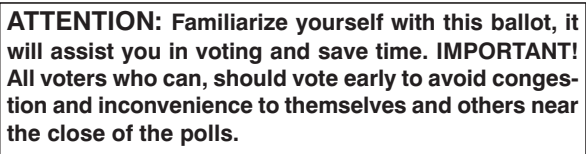

The early voting locations are listed below. Hours for early voting are Friday-Saturday, 10am to 8pm and Sunday 10am to 6pm. It doesn't matter where you live in Morris County - registered voters can go to any of the 8 sites and conveniently cast your ballot on a voting machine.

In cases where the sample ballot is to be sent an addressee who does not receive his mail by delivery to his home or through rural free delivery "if not delivered within five days return to the Superintendent of Elections" and in all other cases "if not delivered within two days return to Superintendent of Elections."
